The meeting was called to order at 5:30 p.m. by Chair, Mayor Jim Hovland

- 1) Welcome and Introductions- James Hovland, Chair, City of Edina
- 2) Adoption of Minutes A motion was made by John Ulrich to approve the November 10, 2011, minutes; the motion was seconded by County Commissioner Vance Stuehrenberg and approved.

3) Financial Reports for November and December – The financial report for November and December 2011 was distributed and reviewed. John Ulrich made a motion to approve the financial reports. The motion was seconded by Vance Stuehrenberg and approved.

#### 4) Annual Meeting

a) Officers – Nominations

The Executive Committee discussed two ways to handle the nomination of officers: 1) establish a nominating committee or 2) survey current officers and see if they would be willing to serve another term. These options will be presented to the full Board for approval. (NOTE: In the future, this process should be handled at the October meeting).

b) 2012 Budget Approval

The proposed 2012 budget was presented to the Executive Committee. Modifications were made to the proposed budget including the addition of language which would result in a balanced budget. A motion was made by Tom Hulting to recommend approval of the proposed budget to the Full Board, including the various modifications that were discussed. The motion was seconded by Jon Ulrich and approved.

c) 2012 Insurance Renewal – Approve Additional Coverage Waiver Executive Committee members reviewed the memo regarding the Tort Liability Waiver. Bob Oberle made a motion to NOT WAIVE the monetary limits on municipal tort liability established by Minnesota Statutes 466.04 for the US Coalition Joint Powers Board for the Board's insurance coverage in 2012. The motion was seconded by Vance Stuehrenberg and approved.

## 5) Corridor Advocate Update

- Report of Subcommittee
   A subcommittee had been established to discuss the anticipated performance of WSB during the upcoming six months.
- Recommended Revisions to Contract
   The subcommittee provided a report out to the Executive
   Committee. Jon Ulrich made a motion to recommend that the Full
   Board accept the terms as outlined by the subcommittee. The
   terms would be laid out in a new contract and the current contract
   would be cancelled. The motion was seconded by Tom Hulting and approved.

A corridor advocate report was distributed.

  - 2012 Board Meeting Schedule Executive Committee members reviewed the draft 2012 Board Meeting schedule. Technical committee members will continue to arrange educational programs for the 2012 meetings.
